An Act to amend the Grenada Citizenship by Investment Act  
No. 15 of 2013.

*[ 19th May, 2017 ].*

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—

1. This Act may be cited as the

Short title.

**GRENADA CITIZENSHIP BY INVESTMENT**  
**(AMENDMENT) ACT, 2017,**

and shall be read as one with the Grenada Citizenship by Investment Act No. 15 of 2013 hereinafter referred to as the “principal Act”.

2. The principal Act is amended by inserting after section 8 the following new section—

**“Commissioners of Oaths**

8A. (1) For the purposes of this section, the Attorney-General duly designated by the Governor-General may appoint fit and proper persons as Commissioners of Oaths.

(2) A Commissioner of Oaths duly appointed under this section may tender to an applicant who is granted citizenship by investment the oath or affirmation of allegiance in any place outside of Grenada.

(3) An appointment under sub-section (2) shall be for the period specified in the instrument of appointment, unless sooner revoked.

(4) A person who wishes to be appointed as a Commissioner of Oaths may submit an application to the Attorney-General in the form set out in the Schedule accompanied by the prescribed non-refundable application fee.

(5) The Attorney-General shall, after due consideration of an application grant, deny or delay for cause an application.

(6) Within twenty-one days of submission of a complete application the Attorney-General shall notify or cause to be notified the applicant of the decision made regarding the application.

(7) The Minister may by Order published in the *Gazette* specify the places outside of Grenada where a Commissioner of Oaths may tender the oath or affirmation of allegiance.

(8) In this section “Commissioner of Oaths” means a person appointed by the Attorney-General under sub-section (1).”.

3. The principal Act is amended by inserting after section 16 the following new Schedule—
