STATUTORY RULES AND ORDERS NO. 41 OF 2020

THE MINISTER IN EXERCISE OF THE POWERS CONFERRED ON HIM BY SECTION 8A (7) OF THE GRENADA CITIZENSHIP BY INVESTMENT ACT NO. 15 OF 2013, MAKES THE FOLLOWING ORDER—

1. Citation. This Order may be cited as the

GRENADA CITIZENSHIP BY INVESTMENT (OATHS AND AFFIRMATIONS OF ALLEGIANCE OUTSIDE OF GRENADA) ORDER, 2020.

2. Definitions. In this Order—

“the Act” means the Grenada Citizenship By Investment Act No. 15 of 2013;

“Commissioner of Oaths” means a Commissioner of Oaths appointed under section 8A of the Act.

3. Specification of places for tendering the oath or affirmation of allegiance.—

(1) The oath or affirmation of allegiance of a person granted citizenship by investment under the Act may be tendered by a Commissioner of Oaths, in addition to within the State of Grenada, at the following places—

- (a) the Embassy of Grenada in the People’s Republic of China;
- (b) the Grenada High Commission in the United Kingdom;
- (c) the Embassy of Grenada in Washington, D.C. in the United States of America;
- (d) the Consulate-General of Grenada in the State of New York in the United States of America;
- (e) the Consulate-General of Grenada in the State of Florida in the United States of America;
- (f) the Embassy of Grenada in Venezuela;

- (g) the Embassy of Grenada in the Russian Federation;
 - (h) the Embassy of Grenada in the Republic of Cuba;
 - (i) the Consulate-General of Grenada in Canada;
 - (j) the Consulate of Grenada in the United Arab Emirates;
 - (k) the Grenada Consular, Trade and Tourism Office in the Republic of Trinidad and Tobago;
 - (l) the Headquarters of the United Nations;
 - (m) a place specified in the instrument of appointment of a Commissioner of Oaths.
- (2) A Commissioner of Oaths may tender the oath or affirmation of allegiance to a person granted citizenship by investment under the Act only at the place specified in his or her instrument of appointment.
